# THE POSITION

The County of Stanislaus, Chief Executive Office invites applications from qualified candidates for the position of Senior Safety & Risk Manager (Manager IV).

Under the direction of the Human Relations Assistant Director, the Senior Safety & Risk Manager is responsible for providing strategic leadership and operational oversight for the County Human Relations Safety and Risk Management Unit to develop, recommend, implement, and drive policies, procedures, and best practices related to Disability Management and Employee Safety functions. Disability Management includes oversight of workers' compensation program administration and Employee Safety includes oversight of all Cal/OSHA and Department of Transportation (DOT) compliance programs as well as safety performance for County departments.

## THE TYPICAL TASKS

- Manage and coordinate all activities in assigned areas of Risk Management programs;
- Conduct comprehensive evaluations of administrative and regulatory issues related to Risk Management programs, including: investigation, evaluation and analysis of complex issues, and the development and reporting of recommendations;
- Advise executive leadership, managers, supervisors, and employees in the interpretation and technical application of Safety and employee leave rules, policies and procedures, and State and Federal employment laws;
- Work closely with executive management and other stakeholders throughout the County on the development of strategic recommendations and action plans impacting the overall administration and operational efficiencies of large agencies and departments;
- Conduct presentations on assigned areas of responsibilities to internal and external entities;
- Negotiate and administer terms and conditions of contracts and other binding documents, and manage and oversee the contracted services;
- Lead various projects, prepare reports and memoranda, write policies, and make presentations; and
- Provide supervision and direction to subordinate staff in all disciplines of HR related to Disability Management, Workers Compensation, Safety, and Risk Management.

# Employee Choice Bonus Plan

## UNDERSTANDING THE DETAILS



### JOIN OUR TEAM BY JUNE 30TH, 2025 TO BE ELIGIBLE!

The following Employee Choice Bonus Plan is designed to allow eligible employees, current active full-time employees or those hired full-time on or before June 30, 2025, to choose one of the three bonus incentive options (one-time option, non-revocable) they would like to receive:



#### Option 1 BONUS CASH PAYMENT

*(Default if employee declines to make a choice)*

- One month of salary (168 hours) paid in cash over three annual installments at the highest step or top of band of the classification held by the employee at each vesting date.
- Minimum amount of each payment will be \$1,666.67 and a maximum payment of \$3,333.37 (base hourly rate of pay for the classification multiplied by 56). The amount of each payment may change depending upon an employee's individual circumstances.
- Total minimum amount received will be \$5,000.01 and maximum will be \$10,000.02 paid over three installments.
- Applicable taxes will be applied and withheld.



#### Option 2 BONUS LEAVE TIME

- 168 hours of bonus leave time allocated within three annual installments.
- Bonus Leave Time would be administered in the same capacity as standard vacation including compensation rate, request and approval, and reporting expectations.
- Bonus Leave Time will have no cash value and cannot be cashed out at resignation, termination, or retirement.
- Must use the bonus leave time prior to the expiration date, as there is no carry over after the bonus leave time expires.



#### Option 3 BONUS DEFERRED COMPENSATION CONTRIBUTION

- One month of salary (168 hours) paid over three annual installments into the employee's Nationwide Deferred Compensation account at the highest step or top of band of classification held by the employee at each vesting date.
- Minimum amount of each payment will be \$1,666.67 and a maximum payment of \$3,333.37 (base hourly rate of pay for the classification multiplied by 56). The amount of each payment may change depending upon an employee's individual circumstances.
- Total minimum amount received will be \$5,000.01 and maximum will be \$10,000.02 paid over three installments.
- Applicable taxes will be applied and withheld.

### Eligibility for Employee Choice Bonus Plan



- Must be an active full-time employee on each vesting date and during the pay period of the payment date to receive each payment.
- Full-time employees on an unprotected unpaid leave on the vesting date are ineligible for that specific payment.
- Employees that separate from full-time service prior to a vesting date will no longer be eligible for that specific payment.
- Employees that receive one or two payments, separate from full-time service and then return to full-time service are excluded from eligibility to receive further payments of any kind.
- Employees that leave full-time service prior to receiving any payments, and then return to full-time service on or before June 30, 2025, are eligible to receive future payments in accordance with their new hire date.

Information on your resume and cover letter will not substitute for the education, work experience and required fields on the County application. The online County application is the primary tool used to evaluate your job qualifications.

## **RECRUITMENT ACCOMMODATIONS**
